SUMMARY ORDER TO VACATE A COUNTY TRAIL

PORTIONS OF OLD PUEBLO TRAIL, IN THE TOWN OF MONTECITO, CALIFORNIA

WHEREAS, the County of Santa Barbara (hereinafter "COUNTY") holder of an easement for that certain trail segment in the unincorporated area of the County of Santa Barbara, State of California, known as Old Pueblo Trail in the town of Montecito (the "Trail"), which Trail was acquired as an easement interest by COUNTY on May 31, 1955 pursuant to Record of Survey Book 36, Page 13 of the Office of the County Recorder; and

WHEREAS, the portions of the Old Pueblo Trail proposed for vacation (collectively the "Portion") are located within County Assessor's Parcel Numbers 007-030-005 and 007-030-019 (herein the "Properties"), which are legally described in Exhibits "A" and "B" attached hereto and incorporated herein by this reference; and

WHEREAS, the proposed vacation would relinquish the COUNTY's easement interests in the Portions; and

WHEREAS, at its regular meeting of September 22, 2020, the COUNTY'S Planning Commission found that relocation of the trail and abandonment of the Portions to be in conformity with the COUNTY'S Comprehensive Plan pursuant to Government Code Section 65402(a); and

WHEREAS, it has been determined by COUNTY'S Community Services Department that, in accordance with Section 892(a) of the California Streets and Highways Code, the Portions are not useful as a nonmotorized transportation facility designed primarily for the use of pedestrians, bicyclists, or equestrians; and

WHEREAS, in accordance with California Streets and Highways Code section 8308, "street" and "highway" include all or part of, or any right in, a trail, or other public right-of-way or easement, or purported public street or highway, and rights connected therewith, including, but not limited to, restrictions of access or abutters' rights, sloping easements, or other incidents to a street or highway; and

WHEREAS, it has been determined by the COUNTY'S Community Services Department that the Portions will be replaced by easements for the Trail located in an acceptable nearby location; and

WHEREAS, it has been determined by the COUNTY'S Community Services Department that the Portions are excess rights-of-way of a street or highway not required for street or highway purposes; and

WHEREAS, no parcels will be landlocked if the vacation of the Portions is consummated; and

WHEREAS, in accordance with California Streets and Highways Code Section 8334(a), the legislative body of a local agency may summarily vacate an excess right-of-way of a street or highway not required for street or highway purposes, and the excess portion meets this criterion; and

WHEREAS, in accordance with Section 8340(c) of the California Streets and Highways Code, the COUNTY is required to reserve and except from the vacation of the Portions any easement and right necessary to maintain, operate, replace, remove, or renew any in-place public utility facilities that are in use; and

WHEREAS, in accordance with California Streets and Highways Code Section 8334.5, a street or highway may be summarily vacated unless there are any in-place public utility facilities that are in use and would be affected by the vacation; and

WHEREAS, COUNTY has contacted all public utility companies operating in the Town of Montecito and determined there are no public utility facilities that are in place or in use within the Portions or that would be affected in any way by the vacation of the Portions.

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of COUNTY does hereby find, determine and order as follows:

- 1. That the above recitals are true and correct.
- 2. The Portions being vacated are unnecessary for present or prospective public use and is not useful as a nonmotorized transportation facility and is excess right of way of a street or highway not required for street or highway purposes since the Portions will be replaced by easements for the Trail located in an acceptable location nearby.
- 3. That the Portions of the Trail on the Properties which are legally described on Exhibit A and Exhibit B attached hereto and incorporated herein by this reference, are hereby summarily vacated as a County trail pursuant to Division 9, Part 3, Chapter 4 of the Streets and Highways Code of the State of California..
- 4. That this Resolution, attested to by the Clerk of the Board under the seal of the Board, shall be recorded in the Office of the County Recorder in the County of Santa Barbara, State of California, and that the date of recording shall become the effective date of this <u>Summary Order to Vacate</u>.

That the Portions of the Trail on the Properties which are legally described on Exhibit A and Exhibit B attached hereto and incorporated herein by this reference, are hereby summarily vacated as a County trail pursuant to Division 9, Part 3, Chapter 4 of the Streets and Highways Code of the State of California..
- 4. That this Resolution, attested to by the Clerk of the Board under the seal of the Board, shall be recorded in the Office of the County Recorder in the County of Santa Barbara, State of California, and that the date of recording shall become the effective date of this Summary Order to Vacate.
