#### **Recommended Actions:**

That the Board of Supervisors consider the following recommendations:

- a) Approve, ratify, and authorize the Chair to execute a First Amendment to the Agreement for Services of Independent Contractor Legacy Philanthropy Works to extend the term through June 30, 2022 to continue support of the data dashboard and its component parts for COVID-19 response in the County without a change in the total amount of \$250,000; and
- b) Determine that the proposed action does not constitute a "Project" within the meaning of California Environmental Quality Act (CEQA), pursuant to Section 15378(b)(4) of the CEQA Guidelines, because it consists of the creation of a government funding mechanism or other government fiscal activities, which does not involve any commitment to any specific project which may result in a potentially significant impact on the environment.

#### **Summary Text:**

This item is on the agenda to authorize the Chair to execute a First Amendment to the Agreement with Legacy Philanthropy Works to extend the term through June 30, 2022 to continue to provide ongoing development, maintenance, troubleshooting, and support of the data dashboard and its component parts as part of the County's COVID-19 response efforts (Attachment A). This agreement was not competed due to emergency needs and because the Public Health Department (PHD) is open to negotiate and work with any vendor that is able to provide qualified data communication services that meet the department's needs during the declared federal emergency period for COVID-19 response.

### **Background:**

As part of the County's response to stop the spread of the Coronavirus, PHD contracted with Legacy Philanthropy Works to create and maintain a comprehensive community data dashboard that includes important local and demographic data regarding COVID-19 testing, new cases, vaccine status, and local hospital capacity. This amendment will allow this work to be continued through June 30, 2022.

#### **Performance Measure:**

Performance measures include providing the following:

- 1. Ongoing development, maintenance, troubleshooting, and support of the data dashboard and its component parts for COVID-19 response in Santa Barbara County; and
- 2. Ongoing facilitation, management, and expansion of the community-based organizations around community impact data; and
- 3. Developing and embedding dashboards in County communications and websites, and assisting in the integration of the data dashboard and its component parts in the recovery planning process.

## **Contract Renewals and Performance Outcomes:**

PHD has had continuous service with Legacy Philanthropy Works as part of the COVID-19 response, and they have provided excellent communications and outreach services for community members in the County.
