Recommended Actions:

That the Board of Supervisors:

- A. Adopt the resolution in Attachment A to establish the classification of Agricultural/Weights & Measures Inspector, Supervising (Class #0334, Range #0334, \$41.045 \$49.890 per hour) and an extra-help-specific Agricultural/Weights & Measures Inspector, Supervising job classification (Class #8634, Range #8634, \$41.045 \$49.890 per hour), and
- B. Determine that the above actions are exempt from California Environmental Quality Act (CEQA) review per CEQA Guidelines Section 15378(b)(4) since the recommended actions are government funding mechanisms or other government fiscal activities which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment.

Summary Text:

The recommended actions would establish the job classification of Agricultural/Weights & Measures Inspector, Supervising in the Agriculture/Weights and Measures Department as well as a corresponding extra-help-specific Agricultural/Weights & Measures Inspector, Supervising job classification. Currently, the Agriculture/Weights and Measures Department uses Supervising Agriculture Biologists and Supervising Weights and Measures Inspectors as two different supervisory-level classifications over two

separate functional areas. The new combined Agricultural/Weights & Measures Inspector, Supervising classification being proposed will improve efficiency and increase productivity. The class will combine the duties of the Supervising Agricultural Biologist and the Supervising Weights and Measures Inspector into one classification that can efficiently supervise staff working in all agricultural and weights and measures programs. This supervisory classification is the next step in the Department's Agriculture/Weights and Measures Inspector series for succession planning, keeping in line with the County's Renew '22 plan. Several comparable agencies including the counties of Marin, Madera, Riverside, San Benito, San Bernardino, San Diego and Solano have similar positions. The position will require more experience, licensing and specialized knowledge in both the Agriculture and Weights and Measures programs, which will provide more efficient supervision of all Agriculture/Weights and Measures Inspector I/II/III positions.

In accordance with the Employer-Employee Relations Policy, all recognized employee organizations were notified of our intent to assign the position to Bargaining Unit 25 (Administrative, Technical, Office & Health Service, Supervisory), represented by SEIU, Local 620, and there were no objections. The County met and conferred with the Union, and the parties reached agreement on the proposed salary, which is based on the median paid by the other agencies.

Background:

In 2017, the Agriculture/Weights and Measures Department established an Agriculture/Weights and Measures Inspector I/II/III classification series, which combined the duties of the Agricultural Biologist I/II/III series, and the Weights and Measures Inspector I/II/III series. The combined series created efficiencies and organizational restructuring that were in line with Renew '22, which resulted in employees that are licensed to perform both functions and provided the Department with flexibility to assign work duties in all programs to any licensed staff.

The new Agricultural/Weights & Measures Inspector, Supervising classification is the next step in the Department's succession planning assuring an efficient and flexible department. The classification will be responsible for assigning, reviewing and participating in the work of the Agriculture/Weights and Measures department programs. The duties of the Agricultural/Weights & Measures Inspector, Supervising include: plan and direct the work of subordinates in all Agriculture/Weights and Measures Department programs, schedule and evaluate work of assigned staff, train staff in all areas of departmental program operations, make presentations at meetings, recommend legal action in response to violations and coordinate special programs with appropriate local, state, and federal agencies. This is a supervisory position that exercises direct supervision over Agriculture/Weights and Measures Inspector staff and is responsible for the effective and efficient operation of the work unit.
