Budget Action: Increase appropriations of \$380,748 in the Behavioral Wellness Mental Health Services Fund for Salaries and Employee Benefits (\$100,645) and Services and Supplies

(\$280,103) funded by unanticipated revenue from the California Board of State and Community Corrections through the Coronavirus Emergency Supplemental Funding

(CESF) Program.

Justification: The Department of Behavioral Wellness submitted a grant application on behalf of the County of Santa Barbara (County) for Coronavirus Emergency Supplemental

Funding (CESF). The total grant award to the County is \$571,122.83 and the grant period runs from March 31, 2021 to January 31, 2022. CESF funds will be used to ensure that individuals who are eligible for Behavioral Wellness services are expeditiously connected with behavioral and housing services upon release from

incarceration.

Behavioral Wellness will use \$380,748 in CESF funds in the current fiscal year; this budget revision is necessary to add the CESF grant to the FY21-22 budget. The

Board approved the CESF Grant acceptance at the meeting held on April 20, 2021.
