FIRST AMENDMENT

Effective January 1, 2022

THIS IS THE FIRST AMENDMENT (hereafter referred to as First Amendment) to the Legacy Philanthropy Works Agreement to provide support of the data dashboard and its component parts for COVID-19 response in the County of Santa Barbara (hereafter Agreement), by and between the County of Santa Barbara (COUNTY) and Legacy Philanthropy Works (hereafter CONTRACTOR).

WHEREAS, the Agreement is effective through December 31, 2021 unless otherwise unless earlier terminated; and

WHEREAS, the parties desire to amend the Agreement to extend the term; and

WHEREAS, Section 25 requires the parties amend the Agreement by an instrument of writing and executed by the parties and by no other means, and

WHEREAS, this First Amendment incorporates the terms and conditions set forth in the Agreement approved by the County of Santa Barbara.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

- <u>Definitions.</u> Capitalized terms used in this First Amendment, to the extent not otherwise 1. defined herein shall have the same meanings as in the Agreement.
- Amendment. Agreement Section 4 "Term" is deleted and replaced in its entirety with: 2. CONTRACTOR shall commence performance on November 1, 2020 and end performance upon completion, but no later than June 30, 2022 unless otherwise directed by COUNTY or unless earlier terminated. This Agreement cancels, nullifies, and supersedes Purchase Order No. CN24395 which included a term of November 1, 2020
- Counterparts. This First Amendment may be executed in several counterparts, all of which 3. taken together shall constitute a single agreement between the parties.
- Effectiveness of Agreement. The terms and provisions set forth in this First Amendment 4. shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, except as expressly modified and superseded by this First Amendment, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding, and enforceable obligations of the Parties.
