- A) Accept a grant from the California Department of Boating and Waterways in the Amount of \$80,000.00 for purchase of a new Ranger Patrol Boat for Cachuma Lake;
- B) Authorize the Director of Parks to execute a grant agreement with the State of California on the terms and conditions described herein (Attachment 1); and
- C) Approve a budget revision request (Attachment 2) for the grant from the California State Department of Boating and Waterways in the amount of \$80,000 to Cachuma Recreation Facility Improvements (project #8602).

Summary Text: The California Department of Boating and Waterways has awarded Santa Barbara County a Grant for the purchase of a new Patrol Boat. Acceptance of this grant will allow Parks to replace an aging Patrol Boat that is 30 years old.

This new Patrol Boat will assist the Department with providing the equipment necessary to promote a safe and enjoyable environment for our customers. In addition, newer equipment is more efficient and reliable and has reduced maintenance and operation costs over the older equipment.
