Ms. Miyasato:

I would like to provide my strong support for the naming of the County owned property at 6549 El Colegio Road, Isla Vista, California as the *Hedges House of Hope*. The County acquired 6549 El Colegio Road on November 12, 2021. According to the County's Naming County Assets policy adopted in November 2021, all requests for naming are to the be submitted in writing to the CEO's office. Father Jon-Stephen Hedges, who passed away February 25, 2021, meets criteria guidelines of contribution and service, and residency. Staff has consulted with the Hedges family and they support this asset naming. While the County's policy requires that naming County assets after a deceased individual is not allowed when the death occurs less than a year from the date of the request, an exception shall be made when there is unanimous approval by the Board of Supervisors.

The Very Reverend Father Jon-Stephen Hedges, Assistant Pastor at St. Athanasius Church in Isla Vista, was a highly regarded community spiritual leader. He served as chaplain with the County Sheriff's Department, Isla Vista Foot Patrol; worked with several community service agencies such as Doctor's Without Walls, American Red Cross and County Departments (CSD, Probation, Public Defender, DSS, BeWell), among others. He trained as a board-certified crisis chaplain with the American Academy of Experts in Traumatic Stress; Certified Trauma Responder (CTR) and Emergency Medical Technician EMT-B) and his training and experience made him uniquely qualified serve and advocate for the unsheltered residents in his community.

He helped develop the St. Brigid Fellowship, which serves unsheltered community residents, and his support for the County Isla Vista Temporary Emergency Shelter and Navigation Center at the Isla Vista Community Center and IV Recreation and Park District site was critical to winning community acceptance of the effort. He also supported the development of a permanent South County Navigation Center, which makes the naming of the current County property as "Hedges House of Hope" a fitting memorial to a brave and dedicated public servant.

Father Jon tended to his flock with devotion, energy, compassion, and kindness as a community organizer, spiritual leader, and social justice advocate. He was known for his ministry to the houseless of Isla Vista, members of his church, victims of tragedy, and first

responders. Father Jon consistently went towards the pain, the suffering and confusion rather than shrinking from it. His mission was to bring comfort to people in dire circumstances. He was known for his compassion, tenacity, and dedication to serving others in Isla Vista and beyond. He lived and led in Isla Vista for 50 years. He was a founding board member of the Isla Vista Community Services District. He was called to comfort and guide countless County residents through times of disaster and tragedies.

Father Jon dedicated his life to three noble endeavors: helping those impacted by tough circumstances, misfortune, bad choices or calamity; nurturing, supporting and fortifying those who are called to respond to their needs; and serving God by doing the first two. Nothing would be more appropriate than naming this building after Father Jon.
