On February 15, 2022, set a hearing for March 8, 2022, to consider Case Nos. 21APL-00000-00062 and 21APL-00000-00063, appeals of the County Planning Commission's October 6, 2021 approval of the Orcutt Gas Station Development Plan and Minor Conditional Use Permit (Case Nos. 18DVP-00000-00001 and 18CUP-00000-00001). The appeals were filed by PR Investments, LLC and Far Western Liquor, Inc.

On March 8, 2022, staff recommends that your Board take the following actions to deny the appeal and approve the Project:

- d) Grant *de novo* approval of the Project, Case Nos. 18DVP-00000-00001 and 18CUP-00000-00001, subject to the conditions of approval.
