On February 15, 2022, set a hearing for March 1, 2022, to consider Case No. 21APL-00000-00032, an appeal filed by Sarah Trigueiro of the Planning Commission's June 9, 2021, approval of the G&K Cannabis Processing Building (Case Nos. 19CUP-00000-00062, 20AMD-00000-00003, and 19CDP-00000-00157).

On March 1, 2022, staff recommends that your Board take the following actions to deny the appeal and approve the Project:

- c) Determine that the previously certified Programmatic Environmental Impact Report (PEIR) (17EIR-00000-00003) is adequate and no subsequent Environmental Impact Report or Negative Declaration is required pursuant to CEQA Guidelines Sections §15162 and 15168(c)(2), and
- d) Grant *de novo* approval of the Project, Case Nos. 19CUP-00000-00062, 20AMD-00000-00003, and 19CDP-00000-00157, subject to the conditions of approval.
