Please take steps to have an open discussion about the plan to build the Galileo Pisa project. This project is far too dense; 16.7 units per acre rather than 4 to 5 units per acre. Additionally it is too tall - buildings in Noleta should be limited to 2 stories maximum and save the character of our neighborhoods and what views we have left. There should be multiple buildings rather than 27 units in one large building. We have already seen what this kind of density did to the aesthetics and traffic in northern Goleta. You can add a reasonable amount of housing without going to this extreme. We have to live here and want to keep a community that looks residential. Additionally, parking should be located in the back of the building, not on Calle Real. I also have huge concerns about where we are going to get water now and in the future to support this kind of density. Please listen to the citizens who have to live here before approving this project.

I am a resident on Orchard Park Lane, off of Calle Real and have very significant concerns about the proposed development of the Galileo Pisa apartment project.

Neighbors,

Big picture...this is likely our neighborhood's last chance to have decision makers fully consider our concerns (many of which are the same issues this developer raised to stop/alter a nearby project...<u>see this link</u>). We need to weigh-in with the Board of Supervisors before next Tuesday's (March 1) hearing. See below.

During a prior Board of Architectural Review (BAR) hearing, they declined talking about density and traffic safety stating that those were issues for the Planning Commission (PC). At December's PC hearing, several commissioners (paraphrasing) concluded that the BAR must have discussed our concerns. Put simply, we need to encourage the Board of Supervisors to have an open discussion of our concerns. Here's how you can help:

Suggested Comments for Emailing Board of Supervisors

As always, keep your comments respectful and succinct. Key issues are below and you can review additional resources. Be sure to put "Galileo Pisa Concerns for Mar 1 Hearing" in your subject line.

- 1. Project is too dense, too tall, and is inconsistent with Community Plan aspirations.
- 2. Proposed access places a turn lane too close to Patterson posing traffic and safety concerns.

3. The <u>developer's own words</u> of concern about a nearby development acknowledge many of the same concerns our neighborhood has about her project.

Although we don't have an estimate on the exact time of day, the "Galileo Pisa" apartment project (333%-417% more density than nearby homes in our neighborhood) is set to be heard by the Board of Supervisors (BOS) on Tuesday, March 1st. This three story building is proposed for the small avocado orchard at Calle Real and Patterson.

Late last year, the Planning Commission essentially ignored our concerns and "recommended" it for consideration by the BOS - - meaning we will have no legislative ability to appeal any BOS action (if they approve it).

All this to say - - in addition to sending emails, you and other concerned neighbors will need to join me at the hearing (via Zoom or in-person). So please block off your calendar for Tues., Mar 1st (I'll relay estimated start time once it's available). As I've said before, I'm grateful for the emails/calls you've sent to our decision makers, yet now is the time to voice our concerns in person. It's literally now or never.

I'm writing to voice my concerns over the high-density building project planned for Calle Real and Patterson in Goleta. This is a 'window' to many family communities to the North. It is the LAST remaining off ramp/on ramp in Goleta that isn't filled with gas stations and businesses.

My primary concerns, outside of wanting the area to remain uncrowded, are that (1) the project is too dense, too tall, and is inconsistent with Community Plan aspirations that were clearly defined. Is the Board aware of this? And (2) the proposed access into the development places a turn lane very close to Patterson - posing traffic and safety concerns. The area is already not safe for pedestrian crossings. The left-turn on Calle Real is already congested as well. I urge you to review the traffic study.
