FIRST AMENDMENT TO

PROFESSIONAL SERVICES AGREEMENT BETWEEN COUNTY OF SANTA BARBARA AND GOOD SAMARITAN SHELTER

HOMELESS MANAGEMENT INFORMATION SYSTEM (HMIS) SUPPORT

THIS FIRST AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT ("First Amendment") is made by and between the

COUNTY OF SANTA BARBARA, a political subdivision of the State of California, hereinafter referred to as "COUNTY",

and

GOOD SAMARITAN SHELTER
a California nonprofit organization,
hereinafter referred to as "CONTRACTOR";

with reference to the following:

WHEREAS, on January 1, 2020, COUNTY and CONTRACTOR entered into a Professional Services Agreement for the Homeless Management Information System (HMIS) Support; and

WHEREAS, the Agreement sets forth CONTRACTOR'S obligations regarding the provision of services and staffing as delineated in Section I, "Scope of Service" and sets forth the staff salaries and benefits eligible for reimbursement in Exhibit B of the Agreement; and

WHEREAS, Section VI.D, "Amendments," of the Agreement provides that COUNTY and CONTRACTOR may amend the Agreement at any time provided that such amendments make specific reference to the Agreement, and are executed in writing, signed by a duly authorized representative of each party, and approved by COUNTY's governing body; and

WHEREAS, on January 14, 2020, the Board of Supervisors approved and authorized a professional services agreement between the COUNTY and the CONTRACTOR; and

WHEREAS, the parties desire to amend the Agreement to extend the term as set forth below, until September 30, 2022; and

NOW, THEREFORE, the parties agree to amend the Agreement, as follows:

1. The first sentence of Section II, "Time of Performance," shall be replaced in its entirety as follows:

Services of CONTRACTOR shall start on the date executed by all parties to be effective as of January 1, 2020 and shall end on September 30, 2022, unless terminated earlier or there are no funds available for

- any reason. If necessary, the term of Agreement and the provision herein may be extended to cover any additional time periods, upon written consent by COUNTY and CONTRACTOR.
- 2. Except as set forth in Section 1 above, this First Amendment shall not modify or change any of the provisions of the Agreement, and the parties to this First Amendment and the Agreement are bound by the provisions of the Agreement, as amended herein.
