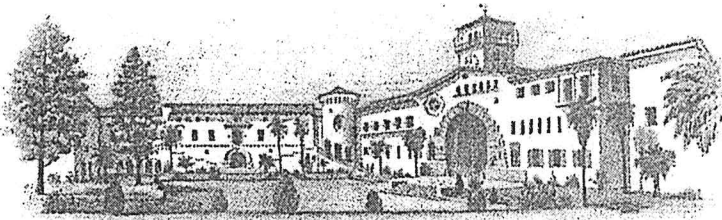

WHEREAS, Jonathan S. Frye began employment with the Santa Barbara County Flood Control and Water Conservation District on January 31, 1994 as a Civil Engineer and was promoted to Engineering Manager in 1998 to oversee the Design, Development Review, and Hydrology Sections within the District, and

WHEREAS, within the first year of Jon's employment the County suffered two devastating flooding events in 1995. Jon distinguished himself following fires and floods with determination and poise as he led response efforts from guiding emergency response work, to developing and constructing emergency projects, to managing an aerial hydromulch treatment of burned hillsides, twice, following the Gap and Jesusita Fires, and

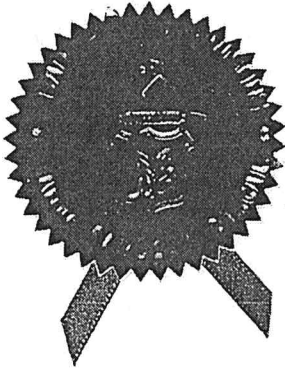
