## **African American Socioeconomic Advancement Project**

**Grant Funds Requested:** \$30,000

Requested Funding Time Period: 6 mo.

Geographic Area Served: North and South County

City: Santa Barbara

**Project Description:** "African American Socioeconomic Advancement Project (AASAP) begins on May 2. AASAP seeks funding for its mission of providing socioeconomic inequality awareness, financial education, grassroot incubation and micro-social enterprise in Santa Barbara north and south county. Through conducting immersive, active research to support the building of cooperatives, coordinated efforts and collaborative coalitions for collective impact.

AASAP will establish three community action teams to implement solutions found during research stage. AASAP will provide information specific to the Black community and its needs. AASAP's goal is to enjoin eight separate efforts into a fluid and innovative relationship based on common purpose, capacity and mission. AASAP will help establish two grassroot groups as pre-501. AASAP will create preliminary action plans for three new non-profit organizations for growth and sustainability. This grant will pay for research project costs, relocation of their operations location due to covid concerns and negative interactions with Lompoc police and their K9 unit. This came at a premium cost. Finally, to replace a team member who left on urgent family business."

#### **Alumni Alliance For Racial Justice**

**Grant Funds Requested:** \$42,000

Requested Funding Time Period: 2 years (24 mo.)

City: Pasadena

**Project Description:** "The Alumni Alliance for Racial Justice (AARJ) is a 501(c)(3) organization committed to dismantling racism and white supremacy in higher education. By coordinating alumni engagement, mobilizing alumni donations, and organizing collective action in support of racial justice, AARJ seeks to utilize the alumni voice to promote structural change and improve policy at predominantly white institutions, prioritizing the safety, education, and well-being of students of color.

AARJ aims to expand one of its most impactful existing programs, the Racially Conscious Therapy Fund. The Therapy Fund seeks to bridge financial gaps and provide students of color with access to mental health professionals trained in treating racial stress and trauma. AARJ believes therapy plays an important role in building support systems, healing racial trauma, and developing lifelong tools and coping strategies, reducing the negative impacts of racial stress on students' future mental health, endeavors, and opportunities.

The project will begin September 2022, in alignment with the academic calendar. Funding received from the FUND will directly finance (in part or in whole) therapy sessions for students of color."

**Project Description:** "The American Institute of Architects - Santa Barbara Chapter's Equity, Diversity, and Inclusion committee, is a sub-group of the AIA – Santa Barbara chapter, whose mission is to serve members, the profession of architecture, and the community by promoting design excellence, professional development, education, and environmental and social equity. This proposal aims to advance the AIA – Santa Barbara mission to promote social equity and to provide resources for the architecture community that otherwise do not exist or are difficult to find. Furthermore, the proposal aims to provide an education series for both AIA members and the community that focuses on social and racial equity in architecture and professional practice. The EDI Committee finalized their 2022 goals at the

start of February and is currently working towards implementing those goals. The project start date is dependent upon receiving funding from the grant, as the committee would use the funds to hire a professional specialist in Equity, Diversity, and Inclusion to help generate resources for the community and launch the education series."

**Project Description:** "BCACSB was founded on the transformational power of the Afro-Brazilian cultural arts to build community and bridge divides caused by systemic racism. BCACSB is a 501(c)3 Non-Profit empowering community members through arts education, inspiring creative self-expression to move beyond physical, mental and emotional challenges. BCACSB is committed to maintaining a safe space for all community members to express themselves and join together to create community. With martial arts, dance, drumming, language and music we encourage our community to embrace diversity and embody self-confidence through classes for all ages and levels.

Funding will support the development and implementation of a teacher training program, led by Mariano Silva, to empower youth teachers as leaders through teaching Capoeira as a tool of transformation and social integration. The first year, starting on April 1, 2022, will be focused on developing the program. The second year will be the first year of training teachers, adapting the program as needed, and reaching out to schools. The third year will focus on ongoing training and mentorship for teachers within schools."

Through forging a regional partnership between social justice, anti-racism, and environmental movements, the network expands the region's collective power to advance restorative actions and systems change. Our work centers on communities who bear the greatest burden of climate change impacts. Funding would support the expansion of capacity for BIPOC leaders across the organizations and communities they serve, including CCCJN, whether it be compensating them for their labor and expertise given to the Network, and/or the hiring of additional staff who would serve as the nexus between the BIPOC organization and the Network."

- 3) Produce multiple community conversations that center the Black American experience and through dialogue we can help communities in Santa Barbara County move towards solutions for racial inequity and and anti-Blackness and provide a model for more a inclusive community.
- 4) Costs associated with hosting 7 community conversations, including speaker and facilitator costs, filming and editing expenses, venue, website maintenance and travel expenses."

**Project Description:** "Starting this year Comité Guelaguetza has regrouped the board, active volunteers, and is restoring the nonprofit status. Guelaguetza Popular in Santa Maria, CA was founded almost 20 years ago by a group of indigenous farm working Oaxaqueños with the vision to preserve and celebrate one of the most traditional and historically

representative ceremonial festivals called Guelaguetza. Guelaguetza celebrates all 8 regions of the state of Oaxaca through traditional food, music, and dances that are unique to each region. This cultural and spiritual event has uplifted the cultural value, dignity, and autonomy of Oaxaqueños, indigenous people in Santa Maria, and the surrounding areas. The funding will be used for educational cultural workshops, the logistics for the festival, and building a sustainable program for years to come."

**Mission Statement:** Our mission is to continue to bring this celebration for children, adolescents, adults, and elders whose culture is honored and represented on this side of the border. Guelaguetza aims to continue this historic celebration while adding collective workshops to build solidarity and resiliency among indigenous community in Santa Maria.

## **Cultural and Creative Arts Center of the Santa Maria Valley**

Project Description: "Funding will support a project focused on arts as a vehicle for racial equity in the Santa Maria Valley. We seek to establish and grow a vibrant suite of programs that bring arts directly to underserved community members, allowing the development of leadership skills and the free expression of creative thought. This is an equity issue unto itself. Within our broader location within social justice movements, the funding will also support our leadership in cultural advocacy and community development work that positively impacts the status of Latinx communities, who are a statistical majority but persistently underrepresented. Funding would specifically support coordination time and supplies, interpreters, and outreach to launch a Free Art Supply Closet in tandem with our regular programming, as well as a Mobile Art Unit. Our organizations' missing is to promote creative expression in the performing, visual and literary arts, preserving the heritages that make our multicultural futures powerful."

## Freedom 4 Youth (F4Y)

**Grant Funds Requested:** \$30,000

Requested Funding Time Period: 3 years (36 mo.)

Geographic Area Served: Countywide

City: Santa Barbara

**Project Description:** "Freedom 4 Youth (F4Y) is requesting \$10,000 annually for three years (total \$30,000) for its Lived Experience Executive Division (LEED), a group entirely composed of people who are currently or formerly incarcerated, to lead advocacy efforts focused on creating systemic change to the criminal legal system.

The mission of F4Y is to uplift and empower at-promise youth to build safe and compassionate communities.

LEED will focus on creating change in Santa Barbara County through meetings with elected officials, providing public comments during governmental or other public meetings, and collaborating with other community-based organizations on criminal legal system oriented initiatives.

Funds will be used to compensate the eight (8) LEED Advocates (estimated to be 10 hours per month at \$20/hour). All aspects of our programming and advocacy will funnel through the LEED group."

## **Gateway Educational Services**

**Grant Funds Requested:** \$52,500

**Project Description:** "Beginning in April 2022, Gateway Educational Services (GES) will expand their initiative to engage and empower Black/African American parents to advocate for equitable and just education in Santa Barbara County.

This proposal seeks to activate Black/African American parent participation in local educational policy decisions; the goal is to form a Black/African American parent advocacy/advisory group to ensure this community is represented in local decision-making that impacts education.

GES will offer two annual town hall webinars "State of African American Students" to highlight the racial inequity in our region and provide engagement opportunities for parents and leaders. Local educational leaders will be invited to better understand the barriers faced by Black/African American students and how to address these barriers. GES believes parent participation in decision-making is crucial to creating an equitable education system."

## Martin Luther King Jr., Day Celebration Committee

The event is done on the birthday of Dr. Martin Luther King Jr. and includes participation from Civic and Social organizations as well as community members from different cultural and ethnic backgrounds. Participants were from Lompoc, Santa Barbara, Santa Maria, San Luis Obispo and Paso Robles. The activities are a welcome community event and help bring people of different cultural and ethnic backgrounds together. The program provides

cultural/ethnic education and historical, civic, and health information. This event strengthens Unity in the community. Funding will cover the cost of, Venues, Grant Writer, and Security."

### **NAACP Santa Maria Lompoc 1072**

**Project Description:** "Found in 1909, in response to the Springfield massacre and the horrific lynching of innocent Black men, we are the nation's largest and oldest civil rights organization with over 2200 branches in the United States, Japan and Germany. Our mission is to ensure the social, political, educational, and economic equality of rights of all persons and to eliminate racial hatred and discrimination. We stand against all forms of injustice and envision a society in which all individuals have equals rights and there is no racial hatred or discrimination.

Our project seeks to dismantle systems of racism, oppression and discrimination by dismantling those systems that perpetuate racism, discrimination and hatred. Funding will support an annual Juneteenth Celebration and Black History Celebration, and a culturally competent program in two junior high schools, one in Santa Maria and one in Lompoc. The

murder of George Floyd and national attention on the number of unarmed Blacks murdered, has made our work more intentional with as we attempt to address "systemic transformative outcomes."
