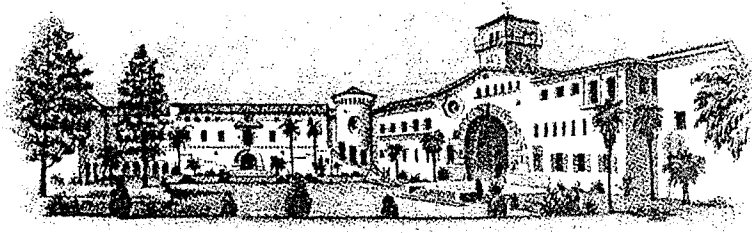

*Resolution of Commendation for District Attorney  
Investigator II Matthew Harvill  
upon his Retirement from the County of  
Santa Barbara District Attorney's Office*

WHEREAS, Matthew Harvill retired from County service on March 31, 2022, having faithfully served the citizens of Santa Barbara County for over 5 years; and

WHEREAS, Matthew has 39 years of Law Enforcement service. He was an officer with the Ventura Police Department, an Investigator with the Ventura County District Attorney's Office, and then started as an Investigator with the Santa Barbara County District Attorney's office in November 2016.

WHEREAS, Matthew was assigned to work on the Golden State Killer investigation and prosecution due to his past experience. When Matthew was working for Ventura Police Department, as a major crimes detective, he was assigned to work an unsolved double homicide from Ventura City. It was ultimately linked to a series of murders by other agencies working the serial killer. Matthew continued to work on the case at the Ventura DA's office where he participated in a task force brought together to solve the murders. When the case was solved, Matthew was again asked to work on the Santa Barbara and Ventura cases as the office representative.

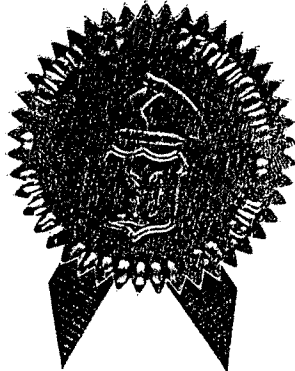
