On April 5, 2022, the Board of Supervisors will consider Case No. 21APL-00000-00033, an appeal filed by Jacqueline Abbud ("Applicant") of the County Planning Commission's denial of the Hacienda Amador Homestay, Case. No. 21HOM-00005.

The applicant is proposing a homestay in two bedrooms of a single-family dwelling, two person limit per bedroom, on a short term basis (less than thirty days). Parking for the homestay will be onsite as shown on the site plan. The property is zoned Agricultural I (AG-I-5), which allows for the use of a permitted Homestay. Quiet hours are from 10pm – 8am. The property owner will continue to reside in the main residence onsite. The property is a 4.98-acre parcel shown as APN 141-100-076, and address as 2905 Via La Selva, Santa Ynez, Third Supervisorial District.
