On May 3, 2022, set a hearing for May 24, 2022, to consider Case No. 22APL-00000-00006, an appeal of the County Planning Commission's March 2, 2022, approval of the 3508 Via Real Development Plan, Minor Conditional Use Permit, and Coastal Development Permit (Case Nos. 19DVP-00000-00020, 22CUP-00000-00005, and 19CDP-00000-00027). The appeal was filed by Jill Stassinos.

On May 24, 2022, staff recommends that your Board take the following actions to deny the appeal and approve the Project:

- Deny the appeal, Case No. 22APL-00000-00006;
- Make the required findings for approval of the Project, Case Nos. 19DVP-00000-00020, 22CUP-00000-00005, and 19CDP-00000-00027, including CEQA findings;
- Determine that the previously certified Programmatic Environmental Impact Report (PEIR) (17EIR-00000-00003) is adequate and no subsequent Environmental Impact Report or Negative Declaration is required pursuant to State CEQA Guidelines Sections 15162 and 15168(c)(2), and

d) Grant *de novo* approval of the Project, Case Nos. 19DVP-00000-00020, 22CUP-00000-00005, and 19CDP-00000-00027, subject to the conditions of approval.
