Responding to Santa Maria Times article of 10/14/21, Oakbrook Lane homeowners wish to note the following: A legal secondary access down Chancellor Street has already been obtained by Key Site 3 Developer. It is odd then, that the article states the Board of Supervisors "lean toward approval of the project" if the Developer obtains approval for secondary access from private homeowners on Oakbrook Lane.

Chancellor Street is a far superior roadway to Oakbrook Lane. Extensive work would have to be done in order for Oakbrook Lane to even be suitable. (Most likely why the Developer chose to obtain approval for Chancellor Street.) It seems then, inexplicable the Board of Supervisors appear ready to approve the project *only if* the Developer can get 10 separate homeowners on a private road to agree to grant access use. The Board should approve the Project as is instead of placing unobtainable roadblocks in the way of housing which the community desperately needs. All concerned should consider that not one of the 12 contiguous parcel owners are willing to allow its use as secondary access point.
