**AMENDMENT NO. 2 TO**  
**AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR**  
**BETWEEN THE COUNTY OF SANTA BARBARA AND**  
**EIDE BAILLY LLP**  
**CONTRACT NO. BC-20-040**

**RECITALS**

**WHEREAS**, the County of Santa Barbara (“COUNTY”), and Eide Bailly LLP, (“CONTRACTOR”), collectively the “Parties” and individually “Party”, entered into an Agreement for Services of Independent Contractor (“Agreement”) with a term ending February 15, 2021, which was subsequently renewed through Amendment No. 1 for a term ending February 15, 2022; and

**WHEREAS**, the Parties wish to revive and amend the Agreement for CONTRACTOR to provide additional Single Audit Major Program services at the cost of \$12,000 and to extend the term to May 31, 2022.

**THEREFORE**, the Parties, for good and sufficient consideration hereto acknowledged, hereby agree as follows:

**AGREEMENT**

1. The Parties hereby amend the Agreement, and CONTRACTOR shall provide Single Audit Major Program services for additional Single Audit Major Program testing services at the cost of \$12,000.
2. CONTRACTOR shall end performance upon completion, but no later than May 31, 2022, unless otherwise directed by COUNTY or unless earlier terminated.
3. This Amendment No. 2 may be executed in counterparts, each of which shall be deemed to be an original, and all such counterparts shall together constitute one and the same instrument.
4. All other provisions of the Agreement remain in full force and effect.

IN WITNESS WHEREOF, each Party has executed this Amendment No. 2 to Agreement for Services of Independent Contractor to be effective on the date executed by COUNTY.




