While progress has been made, many of the conditions facing women in Santa Barbara County at the formation of the Women's Commission continue to be areas of concern. Childcare, domestic violence, equality, representation in government, and the high cost of living continue to impact women and children throughout the County of Santa Barbara. Contemporary concerns have also been added to the list, expanding gender identity and including trans and nonbinary communities in the definition of women. This shift requires representation on the Women's Commission that is LGBTQ+ inclusive. As an openly queer, non-binary, young professional with a decade of serving Santa Barbara County through my work as both a professional and community volunteer, I believe my life experience uniquely qualifies me to represent my community on the commission. I have been privileged to be able to survive in Santa Barbara County as a young person of color. It is a struggle every single day to be able to afford to live in this area, and I am honored to be able to be giving of my time to speak for the most vulnerable in our community. The struggle, especially during the height of the COVID-19 pandemic, made it very difficult for so many women and families facing domestic violence and difficult family situations. As a survivor, I know all too well how difficult it is to leave these situations, and want to share my experience so the County of Santa Barbara can make the best funding and policy decisions when it comes to getting women and LGBTQ+ folks out of toxic household environments and into safe spaces. Being of mixed-race background, I have a unique view of what it means to be seen as a Latine person in Santa Barbara County and work regularly in both my professional and volunteer capacities with the organizers working with marginalized community members who have limited access to government due to language barriers or disabilities.
