Recommended Actions:

- a) Approve and authorize the Chair to execute a Third Amendment to the Agreement with Child Abuse Listening Mediation (a local vendor), to provide Targeted Community-Based Child Abuse and Neglect Prevention Services for a total contract amount not to exceed \$125,000 for the period of July 1, 2022 through December 31, 2022;
- b) Approve and authorize the Chair to execute a Third Amendment to the Agreement with Family Service Agency of Santa Barbara County (a local vendor), to provide Targeted Community-Based Child Abuse and Neglect Prevention Services for a total contract amount not to exceed \$83,500 for the period of July 1, 2022 through December 31, 2022; and
- c) Determine that the activity is not a "Project" subject to California Environmental Quality Act (CEQA) review per CEQA Guideline Section 15378(b)(5), since the activity is an organizational or administrative activity of government that will not result in direct or indirect physical changes in the environment.

Summary Text:

These items are on the agenda in order to approve the Third Amendments to the Agreements with Child Abuse Listening Mediation (CALM) for a total contract amount not to exceed \$125,000 and Family

Service Agency of Santa Barbara (FSA) for a total contract amount not to exceed \$83,500 to provide Targeted Community-Based Child Abuse and Neglect Prevention Services (CANP) for the period of July 1, 2022 through December 31, 2022.

The objective is for CALM and FSA-SMVYFC to provide an array of trauma-informed and evidence-based child abuse and neglect prevention services to families in the Santa Maria Valley, Lompoc, Santa Ynez Valley, and south Santa Barbara County. Services will reduce risks and build protective factors, providing targeted support to parents and primary caregivers of young children, and will address the underlying causes of general neglect, including mental health needs, parental substance abuse and intimate partner violence. Services will include but are not limited to referrals and linkages for basic needs support, home visitation, parent education, mental health services, case management, and parent leadership development.

Background:

Santa Barbara County Department of Social Services (DSS) is committed to providing family-centered, strength-based CANP services in collaboration with its community partners. DSS is also committed to ensure that the available funding is used in the most strategic and integrated fashion to promote a comprehensive system of care that addresses the need for early identification and prevention services that are open and accessible to all families, while linking parents and children to intervention and treatment services as needed.

CALM, in collaboration with Santa Ynez Valley People Helping People, Dorothy Jackson Center of Lompoc and Isla Vista Youth Projects will provide CANP services county-wide. The majority of services will be provided in South and Mid-Santa Barbara County. FSA, in collaboration with the Guadalupe Little House by the Park, will provide child abuse and neglect prevention services in Northern Santa Barbara County. Specific services include case management, evidence-based parent education, home visitation, information and referrals, and mental health services for families at-risk of child abuse and neglect.

In 1983, the Legislature passed Assembly Bill 2994, which authorized the creation of the County's Children's Trust Fund (CTF), a local fund specifically designated in law for community-based child abuse and neglect prevention activities. The purpose of the CTF is to fund child abuse prevention and intervention programs. Revenue sources for the CTF consist of fees from birth certificates, pursuant to Section 18968 of the Welfare and Institutions Code, and fees from special license plate sales. Santa Barbara County Board of Supervisors (BOS) is responsible for approving all funding recommendations for the CTF (Welfare and Institutions Code 18697). DSS is responsible for administering all funds at the local level, with oversight from various community councils, including the Santa Barbara County Child Abuse Prevention Council and the KIDS Network.

In addition to the CTF, three federal and state funding sources are available to the County for child abuse and neglect prevention and intervention. Federal funds include Community Based Child Abuse Prevention (CBCAP) funds, and the Promoting Safe and Stable Families (PSSF) grants. Child Abuse Prevention, Intervention and Treatment (CAPIT) funds are state realignment funds.

As in prior funding cycles, federal, state and local child abuse prevention funds available for community-based services were integrated into one request for proposal to align services along priority outcomes based on the Five-Year Plan for Child Abuse and Neglect Prevention. The most recent Five-

Year Plan was accepted by the California Department of Social Services (CDSS) Office of Child Abuse Prevention on April 24, 2018, and was approved by the BOS as part of the 2017 Santa Barbara County System Improvement Plan on May 15, 2018.

A request for proposals (RFP) was released on November 28, 2018 for the prevention of child abuse and neglect in Santa Barbara County, with an emphasis on community-wide coordination and collaboration, evidence-based programming and measurable community impact. Following a comprehensive evaluation, contracts were awarded to CALM and FSA.

DSS and the State are in the middle of completing the County Self-Assessment (CSA), which will inform the new Five Year System Improvement Plan (SIP). The SIP is used to develop the language in the Scope of Services included in the RFP for CANP services. As a result of the State's delay in completing the CSA/SIP, DSS is requesting to extend the current contracts with CALM and FSA through December 31, 2022 to allow for DSS to conduct the RFP process and ensure that the RFP aligns with the County needs and desired outcomes identified in the CSA. According to MPP section 23-622.2, if the county is unable to renegotiate the contract for the extended term, the county shall be permitted to extend the existing contract for a period not to exceed six (6) months if such an extension is necessary to allow time for new bidding.

Performance Measure:

CALM Performance Measures

- 1. 75% of families who score 'in-crisis' or 'at-risk' will show measurable improvement with at least one follow-up assessment, as measured by the Family Development Matrix (FDM). (Objective Met 100% as of Quarter 2 (Q2) Fiscal Year (FY) 2021/2022)
- 2. 85% of parents receiving therapeutic services through CALM will maintain or improve positive parenting attitudes related to reduced risk of child abuse, including appropriate developmental expectations, positive parent-child roles, positive beliefs against corporal punishment, and empathy for their children following six months of treatment, as measured by any one domain on the Adult Adolescent Parenting Inventory version 2 (AAP2.1). (Objective Met 100% as of Q2 Fiscal Year (FY) 2021/2022)
- 3. 85% of referrals for concrete support will result in successful access to services, as measured by referral tracking and follow-up. (Objective Met 80% as of Q2 FY 2021/2022)
- 4. 75% of families receiving prevention services (Parent education or home visitation) will maintain or improve positive parenting attitudes related to reduced risk of child abuse, including appropriate developmental expectations, positive parent-child roles, positive beliefs against corporal punishment, and empathy for their children as measured by any one domain on the AAPI-2. (Objective Met 88% as of Q2 FY 2021/2022)
- 5. 90% of families receiving CANP services will rate their overall satisfaction with services between good and excellent as measured by the Client Satisfaction Questionnaire. (Objective Met 100% as of Q2 FY 2021/2022)

FSA Performance Measures

- 1. 80% of parents/caregivers completing the evidence-based Nurturing Parenting Program will reduce their overall risk for child abuse and neglect upon program completion, as measured by the AAP2.1. (Objective Met 100% as of Q2 FY 2021/2022)
- 2. 80% of families completing the evidence based Strengthening Families Program will show improvements in family satisfaction/parenting sense of competence as measured by the Strengthening Families Program Pre and Post Assessments.
- 3. 80% of case management indicators identified 'in-crisis' or 'at-risk' will show measurable improvement with at least one follow-up assessment, as measured by the FDM. (Objective Met 57% as of Q2 FY 2021/2022)
- 4. 80% of referrals for concrete support will result in successful access to services, as measured by referral tracking and follow-up. (Objective Met 100% as of Q2 FY 2021/2022)
- 5. 80% of parents surveyed will report that they are 'Mostly Satisfied' or 'Very Satisfied' with the assistance they receive, as measured by the Consumer Satisfaction Questionnaire. (Objective Met 100% as of Q2 FY 2021/2022)

Narrative:

Approval and execution of these funding recommendations will result in total direct Agreement expenditures of no more than \$208,500. Appropriations and funding for FY 2022/2023 are included in DSS' recommended budget under the Social Service Programs division. The Agreement will be fully funded in part by the 2011 State Realignment through the CAPIT funds and by federal funds through the PSSF funds. Execution of the Agreements will not result in additional General Fund contributions. The Agreements include a clause that allows the County to reduce the contracted "not-to-exceed" amount if revenues are not realized at the DSS's anticipated level.

Key Contract Risks:

The risk assessment worksheet has been completed and DSS has determined that CALM is a medium risk vendor. The County has experience with CALM and is confident of its ability to provide services.

The risk assessment worksheet has been completed and DSS has determined that FSA is a medium risk vendor. The County has experience with FSA and is confident of its ability to provide services.
