#### NOTICE

Each project applicant shall remit to the county clerk the environmental filing fee before or at the time of filing a Notice of Determination (Pub. Resources Code, § 21152; Fish & G. Code, § 711.4, subdivision (d); Cal. Code Regs., tit. 14, § 753.5). Without the appropriate fee, statutory or categorical exemption, or a valid No Effect Determination issued by the California Department of Fish and Wildlife (CDFW), the Notice of Determination is not operative, vested, or final, and shall not be accepted by the county clerk.

#### COUNTY DOCUMENTARY HANDLING FEE

The county clerk may charge a documentary handling fee of fifty dollars (\$50) per filing in addition to the environmental filing fee (Fish & G. Code, § 711.4, subd. (e); Cal. Code Regs., tit. 14, § 753.5, subd. (g)(1)). A county board of supervisors shall have the authority to increase or decrease the fee or charge, that is otherwise authorized to be levied by another provision of law, in the amount reasonably necessary to recover the cost of providing any product or service or the cost of enforcing any regulation for which the fee or charge is levied (Gov. Code, § 54985, subd. (a)).

Within 30 days after the end of each month in which the environmental filing fees are collected, each county shall summarize and record the amount collected on the monthly State of California Form No. CA25 (TC31) and remit the amount collected to the State Treasurer. Identify the remittance on Form No. CA25 as "Environmental Document Filing Fees" per Fish and Game Code section 711.4.

#### The county clerk shall mail the following documents to CDFW on a monthly basis:

- ✓ A photocopy of the monthly State of California Form No. CA25 (TC31)

CCANY DISAMA PORTAN The project or activity identified below is determined to be exempt from further environmental review requirements of the California Environmental Quality Act (CEQA) of 1970, as defined in the State and County Guidelines for the implementation of CEQA.

**APN:** Multiple (within existing LCSD easement)

Location: Along the existing trunk sewer line located west of the Santa Maria Public Airport from Blosser Road west approximately 3 miles to the Laguna County Sanitation District wastewater reclamation plant.

Project Title: North Trunk Sewer Rehabilitation

Project Description: Pipe lining of approximately 4,276 linear feet of 24 inch diameter asbestos cement sewer pipe (ACP) and 11,287 linear feet of 21 inch diameter ACP with a trenchless, cured in place pipe (CIPP) rehabilitation (Figure 1). Prior to lining, the pipe will be removed from service by above ground bypass pumping from the upstream to downstream manhole. Secondary containment around bypass pumps and a complete backup pumping system will be provided. The ACP was installed in the 1960s and based on recent video surveys has been determined to be in deleterious condition, having exceeded its expected useful life of 50 years and is subject to failure. This project is planned to be completed in sections over the course of several years for budgetary reasons.

The proposed North Trunk Sewer Rehabilitation work is consistent with repair and maintenance activities identified in the Final Habitat Conservation Plan (HCP) Laguna County Sanitation District Facilities Construction, Operation, and Maintenance Western Santa Maria Valley, Santa Barbara County, California (Santa Barbara County Public Works Department, February 2017) and Incidental Take Permit (ITP) Number TE16913C-0. Applicable avoidance and minimization measures identified in HCP/ITP will be implemented during the repair work.

Cite specific CEQA and/or CEQA Guideline Section: CEQA Guidelines Section 15301(b).

Reasons to support exemption findings: CEQA Guidelines Section 15301(b) provides a categorical exemption for the repair, maintenance, or minor alteration of existing publicly owned utilities used to provide sewerage involving negligible or no expansion of use. Consistent with this exemption, the proposed project involves the phased repair and maintenance of an existing trunk sewer pipeline which, based on video surveys, requires remedial lining to ensure it's continued function and to prevent possible failure. The proposed repair and maintenance would not result in any expansion of use. Therefore, the North Trunk Sewer Rehabilitation project can be found to be categorically exempt.

There is no substantial evidence that there are unusual circumstances (including future activities) resulting in (or which might reasonably result in) significant impacts which threaten the environment. The exceptions to the categorical exemptions pursuant to Section 15300.2 of the State CEQA Guidelines are:

(a) Location. Classes 3, 4, 5, 6, and 11 are qualified by consideration of where the project is to be located -- a project that is ordinarily insignificant in its impact on the environment may in a particularly sensitive environment be significant. Therefore, these classes are considered to apply all instances, except where the project may impact on an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies.

CEQA Guidelines Section 15301 is a Class 1 exemption; therefore, this exception does not apply.

(b) Cumulative Impact. All exemptions for these classes are inapplicable when the cumulative impact of successive projects of the same type in the same place, over time is significant.

The project involves the phased repair and maintenance an existing trunk pipeline to allowed continued operation and to prevent potential failure. In addition, there are no other identified projects which would contribute to cumulative impacts. Therefore, this exception does not apply.

(c) Significant Effect. A categorical exemption shall not be used for an activity where there is a reasonable possibility that the activity will

have a significant effect on the environment due to unusual circumstances.

The project involves repairs to prevent potential failure of the pipeline that could result in environmental impacts. Measures will be implemented to safely reroute sewer service around the section of pipeline being maintained. The proposed project passes through potential habitat for the California Tiger Salamander, but is within the existing sewer easement. In addition, the maintenance work is consistent with repair and maintenance activities identified in the Final Habitat Conservation Plan (HCP) Laguna County Sanitation District Facilities Construction, Operation, and Maintenance Western Santa Maria Valley, Santa Barbara County, California (Santa Barbara County Public Works Department, February 2017) and Incidental Take Permit (ITP) Number TE16913C-0. Applicable avoidance and minimization measures identified in HCP/ITP will be implemented during the repair work. Therefore, this exception does not apply.

(d) Scenic Highways. A categorical exemption shall not be used for a project which may result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway. This does not apply to improvements which are required as mitigation by an adopted negative declaration or certified EIR.

The project does not involve a scenic highway or a project which may result in damage to a scenic resource, removal of trees, rock outcropping or similar resource. Therefore, this exception does not apply.

(e) Hazardous Waste Sites. A categorical exemption shall not be used for a project located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code.

The proposed project is within existing LCSD easements and would involve lining an existing subsurface pipeline and temporarily bypassing sewage through an aboveground pipeline. The project would not involve ground disturbing activities that would impact hazardous waste sites. Therefore, this exception does not apply.

(f) Historical Resources. A categorical exemption shall not be used for a project which may cause a substantial adverse change in the significance of a historical resource.

The project involves the maintenance and repair of an existing sewer pipeline; no historical resources would be impacted. Therefore, this exception does not apply.


