AGREEMENT

THIS AGREEMENT, is made between the COUNTY OF SANTA BAR-BARA, a political subdivision of the State of California, hereinafter referred to as COUNTY, and ISLA VISTA RECREATION AND PARK DISTRICT, a Municipal Corporation, hereinafter sometimes referred to as DISTRICT.

WHEREAS, County desires to reconstruct a portion of Picasso Road abutting "Childrens Park" which is not now needed for County road purposes; and

WHEREAS, District owns said park abutting Picasso Road and desires County to cease to maintain a portion of Picasso Road and grant an Encroachment Permit to District so that said portion may be used for Park purposes, all as shown on the Engineering Plan for said project; and

WHEREAS, it appears to be in the public interest and in the interest of the parties hereto that the said improvements on Picasso Road be constructed and that District convey an additional Road Easement to County to construct a cul-de-sac thereon.

NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. The project to be undertaken shall include the grading, placement of aggregate base, asphaltic concrete paving, curb and gutters for the new reconstruction of the road.

County will also remove the curb, gutters, and paving on Picasso Road lying on the south side of that portion of Picasso Road lying westerly of the cul-de-sac to be constructed in accordance with engineering plans prepared by the County of Santa Barbara and on file in the Office of the Director of Transportation entitled as follows: Picasso Road Traffic Barrier at Camino Del Sur, Job No. 320152 dated January 1978, which engineering plans are made a part of this Agreement by this reference.

2. County agrees to prepare the Specifications and Contract Documents and to advertise and call for bids for the construction of said project and execution of the Contract with the Contractor. The County shall provide all necessary inspection and supervision of the work during the course of the construction project, and County shall pay the costs of construction of the curb and gutter, removal of roadway, the new cul-de-sac, and the new entrance at Camino Del Sur.

TO THE RESIDENCE OF THE PROPERTY OF THE PROPER

- 3. District agrees to convey to County, a Road Easement for the additional road right of way needed in the form of a Right of Way Grant, a copy of which is attached to this Agreement labeled Exhibit "A" and which Grant is made a part hereof.
- 4. District further agrees to maintain, at no expense to County, that portion of Picasso Road utilized for park purposes, and to save the County harmless from any injury to persons and damages to property resulting from said park use purposes, insofar as permitted by law.
- 5. County agrees to remove the said portion of Picasso Road from the County Maintained Road System, and to grant an Encroachment Permit to District to use the said portion for park purposes.
- 6. District further agrees to save and hold harmless County from any liability and to reimburse County for any damages arising out of the loss of use and access by adjoining property owners to that portion of Picasso Road which will be removed from the County Maintained Road System and covered by the Encroachment Permit.
