Recommended Actions:

That the Board of Supervisors:

- a. Approve, ratify, and authorize the Chair of the Board to execute a fourteenth amendment to the agreement with TriTech Software Systems, a Central Square Technologies company, dated June 27, 2006, that extends the annual maintenance agreement for the Computer Aided Dispatch System through March 31, 2023, at the cost of \$206,311.50;
- b. Approve, ratify, and authorize the Sheriff, or his designee, to execute the Renewal of Software Support Agreement to extend the term to March 31, 2023, to renew the CAD to CAD Unify license in the amount of \$21,676.03, to renew the current additional 20 Field Ops Subscriptions for a prorated annual amount of \$1,878; and to add an additional 55 Field Ops Subscriptions for an annual subscription amount of \$6,600;
- c. Approve, ratify, and authorize the Sheriff, or his designee, to execute Quote Q-89898 for the addition of 55 Field Ops Subscriptions; and
- d. Determine that the activity is not a "Project" subject to California Environmental Quality Act (CEQA) review per CEQA Guideline Section 15378(b)(5), since the activity is an organizational or administrative activity of government that will not result in direct or indirect physical changes in the environment.

Summary Text:

On June 26, 2006, the Board of Supervisors approved the purchase of the TriTech Computer Aided Dispatch (CAD) System for use in the County Public Safety Dispatch Center run by the Sheriff's Office. The CAD system has been operational for over 10 years and the payment for the annual maintenance and license fees is now due (Attachment C).

The current amendment also seeks to renew twenty Field Ops licenses and further expanding our use of Field Ops by adding fifty-five additional licenses to the agreement (Attachments D and F). Field Ops is an application that Sheriff's Office currently uses that allows emergency users direct limited access to CAD, allowing for an alternative way to contact dispatch directly through the CAD system.

The purchase of Unify CAD to CAD was approved by the Board of Supervisors on June 22, 2021. Unify CAD to CAD allows the Sheriff's Office CAD system to view other participating agencies CAD systems and vice versa. This allows agencies to see and dispatch the closest resource in real time to an emergency call without having to make additional phone calls to determine if a piece of equipment is available and their actual location at the time of the emergency. (Attachment H) Since it was a supplemental purchase, the billing date does not match up with our annual maintenance agreement. The invoice this year is being prorated so that in future years, it can be included in the overall annual maintenance agreement.

The cost of the annual maintenance exceeds the authority of the County Purchasing Agency, so we are requesting that the Board authorize the Sheriff to execute this amendment and pay the support and maintenance agreement cost of \$236,466.

Background:

The Santa Barbara County Public Dispatch Center provides dispatching services to Santa Barbara County Sheriff, Santa Barbara County Fire, and American Medical Response (AMR) upon receipt of 9-1-1 telephone calls. The Dispatch Center also provides dispatching services for several contract cities. The CAD system provides immediate resource recommendation based on the jurisdiction and type of emergency (or non-emergency). In January 2005, the Board of Supervisors entered into an agreement with AMR for contract ambulance services (Attachment G). That agreement stipulated that the County Sheriff purchase and implement the TriTech CAD System. The CAD system was installed in 2006. The annual maintenance contract and related costs are handled in a contract amendment process.
