

AMENDMENT No. 1 to the AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This is Amendment No. 1 to the Agreement between THE COUNTY OF SANTA BARBARA (hereinafter "County") and CivicPlus, LLC, (hereafter CONTRACTOR).

WHEREAS, on April 20, 2021, the parties hereto entered into an Agreement for Services of Independent Contractor (BC21002) (hereinafter "Agreement"); and

WHEREAS, the parties hereto desire to amend the Agreement ("First Amendment"), in accordance with the provisions of the Agreement to extend the term of the Agreement for fiscal year 2022-2023 and increase the maximum contract amount.

NOW, THEREFORE, County and Contractor agree as follows:

I. Section 2 – Scope of Services shall be modified to state:

CONTRACTOR agrees to provide services to COUNTY in accordance with the CivicPlus Agreement dated April 20, 2021 ("Services Agreement") and the applicable Orders or Statement of Work (SOW) attached hereto as EXHIBIT A and A-1 and incorporated herein by reference

II. Section 3 – Term of the Agreement shall be modified to state:

CONTRACTOR shall commence performance on July 1, 2021 through June 30, 2023, unless otherwise extended.

III. Exhibit A-1 – Santa Barbara Renewal Quote for subscription purchases, licenses, and support for July 1, 2022 to June 30, 2023 in an amount not to exceed \$218,871.98 shall be added to the agreement as Exhibit A-1 and is incorporated herein by reference. Contractor shall perform the services set forth in Exhibit A-1.

IV. Exhibit B – Payment Arrangements shall be modified to add section B which shall state:

For CONTRACTOR services to be rendered under this Agreement for the renewal period of July 1, 2022 through June 30, 2023, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed \$218,871.98. Payment shall be made for the annual fee within 30 days of the receipt of correct and complete invoices from CONTRACTOR.

V. Except as otherwise amended by this First Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect.

VI. The signatories to this First Amendment have the authority to bind the parties. This First Amendment may be executed in counterparts, each of which shall be deemed to be an original, and all of such counterparts shall together constitute one executed original instrument.
