## SECOND AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

THIS SECOND AMENDMENT to the Agreement for Services of Independent Contractor (hereafter the "Second Amendment"), is made and entered into this twelfth day of July 2022, by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter "County") and Community Solutions, Inc. (hereafter "Contractor"). For purposes of this Second Amendment, the County and Contractor shall be referred to collectively as the "Parties."

WHEREAS, Parties entered into an Agreement for Services of Independent Contractor with an effective date of July 1, 2019, (hereafter the "Agreement"), by which Contractor agreed to provide counseling and case management services to the Sheriff's Treatment Program; and

WHEREAS, Parties desire to amend the Agreement to extend the term.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, it is mutually agreed upon as follows:

- The term of the Agreement, Section 4, Term, shall be amended to: CONTRACTOR shall commence performance on July 1, 2019, and end performance upon completion, but no later than June 30, 2023, unless otherwise directed by COUNTY or unless earlier terminated.

- 3. Exhibit B-1 Amended is added to the Agreement.
- 4. In all other respects, the terms and conditions of the Agreement shall continue unchanged and in full force and effect.
