UNIT AS A LANTERMAN-PETRIS-SHORT-DESIGNATED
5150 FACILITY

Whereas, California Code of Regulations, title 9, section 821 authorizes county board of supervisors to designate facilities for the treatment and evaluation of persons with mental health disorders detained under Welfare and Institutions Code section 5150 et seq. ("5150") of the Lanterman-Petris-Short Act ("LPS"), subject to the approval of the California Department of Health Care Services;

Whereas, Dignity Health dba Marian Regional Medical Center Crisis Stabilization Unit seeks to provide assessment and stabilization services to individuals detained under the LPS 5150 legislation and related authorities;

Whereas, the services that Dignity Health dba Marian Regional Medical Center Crisis Stabilization Unit desires to provide to individuals in psychiatric crisis will ensure the safety and wellbeing of these individuals and contribute to the overall health of the community;

Whereas, the Santa Barbara County Psychiatric Health Facility was previously designated by the Santa Barbara County Board of Supervisors and approved by the State as an LPS 5150-designated facility; and

Whereas, Dignity Health dba Marian Regional Medical Center Crisis Stabilization Unit and the Santa Barbara County Psychiatric Health Facility will be the LPS 5150-designated facilities in Santa Barbara County.

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDERED AND RESOLVED that:

- The County of Santa Barbara designates Dignity Health dba Marian Regional Medical Center Crisis Stabilization Unit for the treatment and evaluation of persons with mental health disorders detained under Welfare and Institutions Code section 5150 et seq. of the Lanterman-Petris-Short Act.
- 2. The following facilities are LPS 5150-designated facilities in the County of Santa Barbara:
 - a. Dignity Health dba Marian Regional Medical Center Crisis Stabilization Unit at 1401 E. Main Street, Santa Maria, California; and
 - b. Santa Barbara County Psychiatric Health Facility at 315 Camino del Remedio, Santa Barbara, California.
