AMENDMENT No. 1 to the PROFESSIONAL SERVICES AGREEMENT (PSA)

This is the First Amendment to the Agreement between THE COUNTY OF SANTA BARBARA (hereinafter "Owner" or "County") and Architectural Resources Group (hereinafter "Consultant").

WHEREAS, on August 18, 2020, the Parties hereto entered into a Professional Services Agreement, BC20169 (hereinafter "Agreement") for architectural services for the Santa Barbara Courthouse Roof Rehabilitation Project ("Project"); and

WHEREAS, the Agreement was initially for a term of 24 months; and

WHEREAS, the Parties hereto desire to amend the Agreement ("Amendment No. 1"), in accordance with the provisions of the Agreement, to extend the term.

NOW, THEREFORE, Owner and Contractor agree as follows:

- 1. Section 2.03 ("Term") of the Agreement is deleted and replaced with the following:
 - Consultant shall commence performance on August 18, 2020 and end performance on completion of its Scope of Work for the Project, but no later than August 18, 2026, unless otherwise directed by County or unless earlier terminated under Section 12 of this Agreement.
- 2. Except as otherwise amended by this Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect.
- 3. The signatories to this Amendment No. 1 have the authority to bind the parties. This Amendment No. 1 may be executed in counterparts, each of which shall be deemed to be an original, and all of such counterparts shall together constitute one executed original instrument.
