

THIRD AMENDMENT TO AGREEMENT FOR SERVICE OF INDEPENDENT CONTRACTOR

THIS THIRD AMENDMENT to the Agreement for Service of Independent Contractor (hereafter the “Third Amendment”), is made and entered into this 30th, day of August 2022, by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter “County”) and the Satellite Tracing of People LLC., (STOP) (hereafter “Contractor”). For purposes of this Third Amendment, the County and Contractor shall be referred to collectively as the “Parties.”

WHEREAS, the Parties entered into an Agreement for Services of Independent Contractor on August 23, 2016, with an effective date of September 1, 2016 (hereafter the “Agreement”), by which Contractor agreed to provide GPS monitoring Services to Sheriff’s Office Alternative Sentencing Unit; and

WHEREAS, the Agreement provides that the term of the Agreement shall commence on September 1, 2016, and end on August 31, 2020;

WHEREAS, the First Amendment was executed extending the term to August 21, 2021;

WHEREAS, the Second Amendment was executed extending the term to August 21, 2022;

WHEREAS, the Parties desire to extend the Agreement for one additional year.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, it is mutually agreed upon as follows:

1. Section 4 of the Agreement is amended as follows:

CONTRACTOR shall commence performance on September 1, 2016 and performance upon completion but no later than August 31, 2023 unless otherwise directed by COUNTY or unless earlier terminated.

- 2. Section 3 of the Participating Addendum shall delete 8/31/2020 and replace with 8/31/23.
- 3. In all other respects, the terms and conditions of the Agreement shall continue unchanged and in full force.




