Re: Official Approval Notification as 1 of 75 Communities in America 2nd 9/11 DAY Flag of Honor Across America Memorials on September 11, 2022.

Dear Dr Scott Whiteley:

Congratulations on being selected as 1 of the 75 Communities designated as a lead public memorial location in America for the 2nd Annual 9/11 DAY Flag of Honor Across America Memorials on September 11, 2022. And thank you for volunteering to unite and keep America's promise that those tragically killed by terrorists on September 11, 2001, will never be forgotten.

Launched in Memory of the 20th Anniversary of that Tragic Day, the 1st 9/11 DAY Flag of Honor Across America Memorials took place in 60 communities in 25 states on Saturday, September 11, 2021, also called 9/11 Day, a National Day of Service and Remembrance, and Patriot Day. This new annual memorial was designed and launched by Global Youth Justice, Inc., and selected by the United States Government as 1 of only 5 official federal projects to support and co-launch on the 20th Anniversary of 9/11 Day in 2021.

Despite launching in the middle of a Global Pandemic, the 1st 9/11 DAY Flag of Honor Across America Memorial Project was the largest national multi-site 9/11 Day Project on the 20th Anniversary of 9/11 Day on September 11th, 2021, and since Federal 9/11 Day began. In 2021, there were 60 Official Public Sites, and 60 communities united to each hold a 9/11 DAY Public Memorial in Memory of 50 different victims from the 2,983 women, children, and men who lost their lives on 9/11/01 (2,977 victims) and 2/26/93 (6 Victims). And, more than 10,000+ adults and youth showed up at these 60 locations, which we have documented with more than 300+ photos.

In 2022, Global Youth Justice, Inc., Federal Agency AmeriCorps, and the United States Government are expanding the 2nd Annual 9/11 Day Flag of Honor Across America Memorial on September 11, 2022. For the 1st time in America, the victims, first responders, and heroes who died from 9/11-Related Injuries, Diseases, Suicide, and other causes from 9/12/01 to 3/31/2022 will be remembered, as Global Youth Justice, Inc. decided the 2nd 9/11 DAY Flag of Honor Across America Memorials Project will take the lead in honoring the memory of an additional 4,431 victims, first responders, and heroes who have died. Therefore, we are increasing lead public memorial locations in America from 60 to 75 communities being selected, and each memorial will be in memory of 65 different victims, instead of 50 in 2021.

However, there is one good exception to all 75 sites having 65 different victims to remember, as 8 are all the same this year. For the 1st time in 2022, all 75 Communities are uniting to remember the 8 children killed that tragic day on 9/11/2001. In memory of the 8 children, and 10 unborn children killed that tragic day, all 75 sites have the 8 children names included in their approximate 65 assigned names.

The United States Department of Justice's Victim Compensation Fund does release the exact number of victims who died after September 11, 2001 (4,431). However, unlike the 2,983 Victims who died on 9/11/01 and 2/26/93, the names of the 4,431 victims who died after are NOT released. Global Youth Justice, Inc. is working with 20+ family groups, EMS/Police/Fire Departments, and others to find the names of those that died after 9/11/2001.

On June 9, 2022, the 75 communities designated Lead Public Memorial Sites for the 2nd 9/11 DAY Flag of Honor Across America Memorials were Priority Shipped a USPS Large Package (with 13 things) to the individual on this letter. A list of the (13) things are included with this e-mail, including 2 free 5-foot 9/11 Flags of Honor w/2,983 Victims on it (and a verification the flags traveled to the crash site of Flight 93 in Pennsylvania). Other items shipped are the 65 victim names assigned to each site, instruction, and tips, 24 logos and more.

Global Youth Justice, Inc. has received over 250 phone calls, emails, and letters from Family of the 9/11 victims. Please know they appreciate your volunteer efforts to ensure their loved ones are Never Forgotten.
