On July 12, 2022, set a hearing for August 23, 2022, to consider the recommendations of the County Planning Commission to approve the Halsell Rezone and Tentative Tract Map project (15RZN-00000-00004 and 15TRM-00000-00011).

On August 23, 2022, to follow the recommendations of the County Planning Commission, your Board's action should include the following:

- a) Make the required findings for approval of the project, Case Nos. 15RZN-00000-00004 and 15TRM-00000-00011, including CEQA findings.
- b) Adopt the Negative Declaration, 17NGD-00000-00009, and adopt the mitigation monitoring program contained in the conditions of approval for Case No. 15TRM-00000-00004.

- c) Adopt a resolution to approve amendments to the Land Use and Development Code Ordinance to revise the Santa Barbara County Zoning Map for Assessor's Parcel Number 103-200-065 from 2-E-1 to 1-E-1 zoning.
- d) Approve Case No. 15TRM-00000-000011 subject to the conditions.
