FIRST AMENDMENT TO THE AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

THIS FIRST AMENDMENT to the Agreement for Services of Independent Contractor, referenced as BC 21-200, by and between the County of Santa Barbara (County), a political subdivision of the state of California, and Santa Barbara County Education Office (Contractor or SBCEO), a California nonprofit benefit corporation, wherein Contractor agrees to provide, and County agrees to accept, the services specified herein (Agreement).

WHEREAS, Contractor represents that it is specially trained, skilled, experienced, and competent to perform the special services required by County, and County desires to retain the services of Contractor pursuant to the terms, covenants, and conditions herein set forth;

WHEREAS, on December 7, 2021, the Board of Supervisors executed the Agreement for Services of Independent Contractor with SBCEO as a subcontractor under the Mental Health Student Services Act (MHSSA) grant award with the Mental Health Services Oversight and Accountability Commission (MHSOAC) in the amount of \$462,788 over a one-year period of October 1, 2021, through September 30, 2022; and

WHEREAS, through this First Amended Agreement, the County and Contractor wish to extend the Agreement term through December 31, 2022, with no change to the maximum contract amount.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

I. Delete <u>Section 4 (Term) of the Standard Terms and Conditions</u> and replace it with the following:

4. TERM.

Contractor shall commence performance on 10/1/2021 and end performance upon completion, but no later than 12/31/2022 unless otherwise directed by County or unless earlier terminated.

- II. Effectiveness. The terms and provisions set forth in this First Amended Agreement shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, except as expressly modified and superseded by this First Amended Agreement, are ratified and confirmed and shall continue in full force and effect and shall continue to be legal, valid, binding, and enforceable obligations of the parties.
- III. Execution of Counterparts. This First Amended Agreement may be executed in any number of counterparts, and each of such counterparts shall for all purposes be deemed to be an original, and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.
