## **Background:**

This project is the second of two County phases that will complete the last gap in a multiuse trail that will connect the City of Santa Barbara path to the Obern Trail. Completion of Phase 2 of this project, along with Phase 1 and a City Project near Calle de Los Amigos will create a continuous, separated facility for bicycles and pedestrians of all ages and abilities extending from Isla Vista to Arroyo Burro Beach and the City of Santa Barbara.
