I have admired her attention to detail and her insistence that any projects associated with her name comply with all state and local regulations. She is knowledgeable in this area and committed to ensuring that all cannabis projects comply with governmental requirements. I am confident she will be a responsible and diligent operator of the proposed project, based on our many conversations about how to ensure compliance with governmental requirements in this new and constantly changing area of regulation.

I have reviewed Shannon's application for the above-referenced cannabis project. My understanding is that the above-referenced project has been designed to:
