Justification: The Jennie A. Knudsen Trust named the Santa Barbara County Animal Services as one of ten residual beneficiaries for the distribution of her estate assets. The balance

of the trust assets is projected at \$1,400,000 and will be divided equally among the ten beneficiaries, so the bequest to Animal Services is anticipated to be approximately

\$140,000. The unanticipated funds will be designated for future use for Animal Service's program needs. The Animal Services program recognizes the Jennie A,
