Title: Public Health: Increase unanticipated revenues & appropriations for STD Prevention & Collaboration

Budget Action: Increase appropriations of \$159,621 in the Public Health Department Health Care Fund for Salaries & Benefits (\$3,892) and Services & Supplies (\$155,729) funded by

unanticipated revenue from the state general fund via the California Department of Public Health STD Control Branch.

Justification: Acceptance of this third amendment will increase the total grant amount by \$319,242 from \$883,547 to \$1,202,789 for the grant term of 7/1/2019 to 6/30/2024. The

additional award of \$319,242 is to be split evenly between FYs 22/23 and 23/24 at \$159,621 per fiscal year. Across both fiscal years, \$159,620 of the additional funding will be used to fund PHD staff to enhance existing activities in the grant program, and for additional outreach and education, while the remaining \$159,622 of additional funding will be used for subcontractor services. A budget revision is included to increase FY 22/23 revenue and appropriation in the amount of \$159,621. The remaining

\$159,621 for FY 23/24 will be incorporated in the 23/24 budget.
