ORDINANCE AMENDING COUNTY CODE
CHAPTER 2 - ADMINISTRATION,
ARTICLE X, SEC. 2-71;
Tuesday, November 1, 2022

NOTICE IS HEREBY GIVEN that, on November 1, 2022, the County Board of Supervisors will consider amending the ordinance Chapter 2, Administration, Article X, Sec. 2-71. Final action is scheduled to be taken on November 29, 2022.

Proposed Amendments to Ordinance. The proposed changes revises language in Sec. 2-71 which: authorizes the County Executive Officer (CEO) to designate supervision/etc. of appointed department heads to designated assistant county executive officers (ACEOs); clarifies the performance evaluation process for appointed department heads; provides that the Board may reevaluate this authority at the time of appointment of a new CEO; and strikes the requirement for the CEO to obtain Board approval to remove any appointed department head.

The project to be considered by the Board of Supervisors includes the following items:

- Consider the introduction (first reading) of an amendment to Article X, Chapter 2 Administration in Attachment A, of the Santa Barbara County Code of Ordinances; and
- Read the title of the Ordinance and waive full reading of the Ordinance; and
- Continue the hearing to the Administrative Agenda of November 29, 2022 to adopt changes to the Santa Barbara County Code of Ordinances, Section 2, Administration, Article X, Sec. 2-71; and
- Find that the proposed actions do not constitute a "Project" within the meaning of California Environmental Quality Act, pursuant to 14 CCR 15378(b)(5), because it consists of organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment.
