## Dear Ms. Negrete,

I am writing to object to the action taken by the Board of Supervisors on December 13, 2022 (page 33 of the minutes), regarding File Reference No. 22-01130 (Final Map of Tract No. 14,608, Legacy Estates/Village Square, 02TRM-00000-00007). In the motion, the Board determined: "...pursuant to the California Environmental Quality Act (CEQA) Guidelines Section 15162, no new effects will occur and no new mitigation measures would be required as a result of the recommended actions because there are no substantial changes proposed, no substantial changes in circumstances, and no new information of substantial importance regarding environmental effects of the project or of the sufficiency or feasibility of mitigation measures, and therefore the recommended actions are within the scope of the environmental review documents for this project [Environmental Impact Report (05EIR-00000-00005) previously certified September 7, 2005] and no new environmental document shall be prepared for this project." (Highlighting added)

I am not sure who the source was that determined there are "no substantial changes in circumstances, and no new information of substantial importance," but they are incorrect, and your decision was made based on faulty or incomplete data.

Of enormous importance is the issue of water. Unlike Santa Barbara or Santa Maria, Los Alamos' only source of water is ground water. While this source has not changed, the recharge into it and draw from it have substantially changed.

- --The 2000 census showed 1372 residents in Los Alamos, the census of 2020 recorded 1839, a 34% increase in population.
- --Since 2019, 8 marijuana farms with Los Alamos addresses totaling <u>328 acres</u> have been licensed by the county, and there are 107 acres more with pending licenses (see below).
- --Of the years since the 2005 EIR Report (05EIR-00000-00005) was prepared, the majority of years have had less rainfall than the average 15 inches we should be getting.

I object to the conclusion that no substantial changes in circumstances have happened and therefore no new EIR should be prepared, and respectfully ask for a new EIR. I look forward to your response and proposed actions in order to remediate this concern.
