

I am writing you about the agenda item for File #23-0084 (Legacy Estates). As you know, the EIR was completed in 2005.

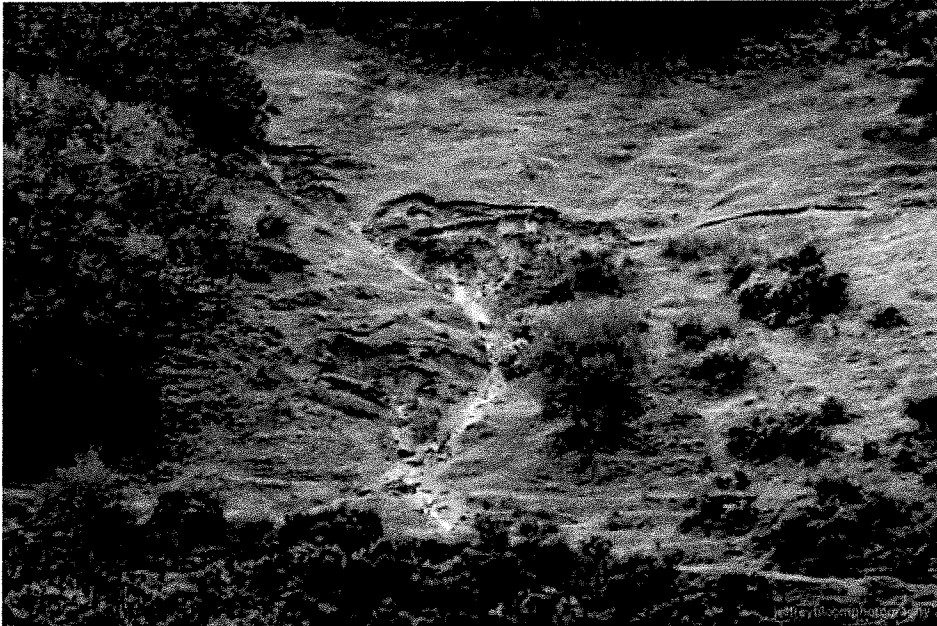
Since that time, California has experienced three historic droughts and historic rains. During the last rains, the current channel for rain runoff next to Den Street from Main to Highway 135 flooded. The bridge across the channel at Waite Street was underwater. Replacing soil with many acres of housing, driveways, and streets will only exacerbate the flooding in this channel.

Given the significant impact climate change has caused and updated regulations since 2005, there is an urgent need for a Subsequent or Supplemental EIR. I ask that you table this item, pending a Subsequent/Supplement EIR.

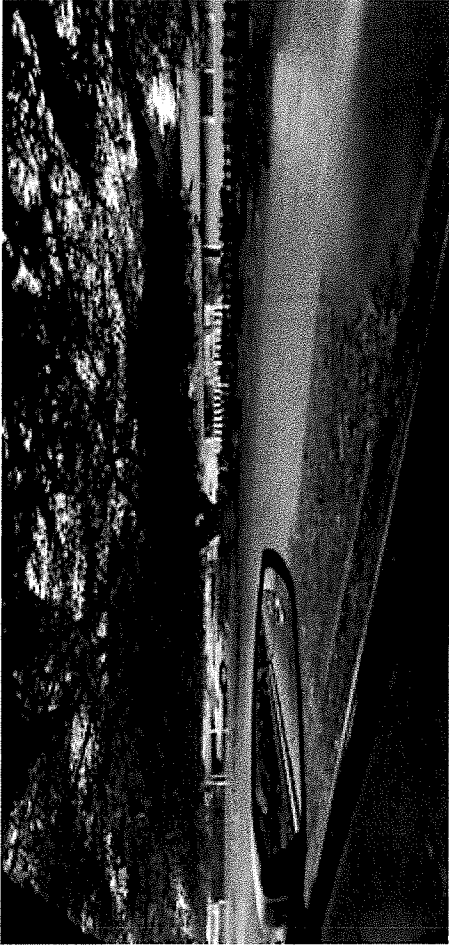
