FIRST AMENDMENT Effective January 1, 2023

THIS IS THE FIRST AMENDMENT (hereafter referred to as First Amendment) to the Agreement for Maddy Emergency Medical Services Fund Distributions (hereafter Agreement), by and between the County of Santa Barbara (COUNTY) and Dignity Health, doing business as Marian Regional Medical Center (hereafter HOSPITAL).

WHEREAS, the parties desire to amend the Agreement established February 7, 2017 and to redefine the term, and to adjust compensation;

WHEREAS, this First Amendment incorporates the terms and conditions set forth in the Agreement, approved by the County of Santa Barbara.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

- 1. <u>Definitions.</u> Capitalized terms used in this First Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.
- 2. **Amendments.** The Agreement is amended as follows:

Section 2 is deleted and replaced in its entirety with:

2. **NOTICES.** Any notice or consent required or permitted to be given under this Agreement shall be given to the respective parties in writing, by personal delivery or facsimile, or with postage prepaid by first class mail, registered or certified mail, or express courier service as follows:

or at such other address or to such other person that the parties may from time to time designate in accordance with this Notices section. If sent by first class mail, notices and consents under this section shall be deemed to be received five (5) days following their deposit in the U.S. mail. This Notices section shall not be construed as meaning that either party agrees to service of process except as required by applicable law.

Section 4 "Term" is deleted and replaced in its entirety with:

4. <u>TERM.</u> HOSPITAL shall commence performance on February 7, 2017, and end performance upon completion, but no later than December 31, 2026, unless otherwise directed by the COUNTY or unless earlier terminated.

Exhibit B "Payment Arrangements" Section A is deleted and replaced in its entirety with:

- A. For HOSPITAL services to be rendered under this Agreement, HOSPITAL shall be paid up to a total Agreement amount, including cost reimbursements, not to exceed \$321,000.
- 3. <u>Counterparts.</u> This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
- 4. Ratifications. The terms and provisions set forth in this First Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, except as expressly modified and superseded by this First Amendment, are ratified and confirmed, shall continue in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.
