Justification: Santa Barbara County has been selected to receive Proposition 47 (Prop 47) Grant funding (\$6 million) over a four-year period (9/1/22 to 6/1/26) from the Board of State

and Community Corrections (BSCC). Prop 47 was a voter-approved initiative that reduced felonies to misdemeanors, specified low-level drug crimes, and property crimes. A percentage of state savings generated by the implementation of Prop 47 is set aside annually for the BSCC to administer a competitive grant program. The BSCC requires awarded Prop 47 grant funds be used to provide mental health services, substance use disorder treatment and/or diversion programs for those in the

criminal justice system.

The Prop 47 grant will fund the Crisis, Recovery, Engagement, Diversion & Outreach, Prop 47 (CREDO47) Program which is a partnership between the following Santa Barbara County departments: Behavioral Wellness, Public Defender, Sheriff, District Attorney, Probation, and local community-based organizations. CREDO47 diverts individuals with a history of mental illness and/or substance use from the criminal justice system to: trauma-informed crisis stabilization, comprehensive mental health and substance use wraparound services, and screening. A Stabilization Center will provide medical monitoring, sobering services, support transitioning from jail and substance use treatment. Step-Down Housing will provide clients with comprehensive case management services, housing assistance, and social services.
