WHEREAS, adequate water for the people, economy, and environment in the County of Santa Barbara is needed in perpetuity; and

WHEREAS, the future reliability of existing water supplies and infrastructure that depend on rainfall, such as surface water reservoirs and groundwater, are uncertain due to changing hydrologic patterns, land use, water use regulations, population growth, and aging infrastructure; and

WHEREAS, water use efficiency practices, low impact development, stormwater capture, and recycled water have been, and are continuing to be implemented, to help extend existing limited water supplies; and

WHEREAS, due to proximity to the ocean, future water supply quantity, quality, and reliability needs, the 2015 Long Term Supplemental Water Supply Alternatives Report identifies partnering with San Luis Obispo County on a regional desalination project as a promising water resource management strategy; and

WHEREAS, while desalination can provide a local, reliable, and sustainable water supply for decades to come, desalination projects take a long time to plan for, permit, and construct; and

WHEREAS, the San Luis Obispo County Flood Control and Water Conservation District intends to develop the Desalination Executable Solution and Logistics Plan (DESAL Plan) over the next several years via a public process that, when complete, will ultimately provide balanced recommendations related to responsibly advancing the implementation of a regional desalination project that will benefit the people, economy, and environment in both Counties; and

WHEREAS, the San Luis Obispo County Flood Control and Water Conservation District will be the lead agency and contract administrator for the DESAL Plan and is requesting that entities that wish to be evaluated during the development of the DESAL Plan adopt resolutions approving participation.

NOW, THEREFORE, the Board does resolve as follows:

- 1. The Santa Barbara County Water Agency wishes to be included in the development of the DESAL Plan and to be evaluated as a potential partner in such a regional desalination project in the future.
- 2. The Public Works Director or designee is hereby authorized and directed to participate in the development of the DESAL Plan and to bring forward related recommendations.
