## **Recommended Actions:**

That the Board of Supervisors:

- A. Approve the amended Conflict of Interest Code of the Buellton Union School District (Attachment C) and
- B. Determine that the above action is an organizational or administrative activity of the government that will not result in direct or indirect physical changes in the environment and is therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(5) of the CEQA Guidelines.

#### **Summary Text:**

The Board of Trustees of the Buellton Union School District adopted its Conflict of Interest Code amendments on September 14, 2022. Amendments to the Buellton Union School District's Conflict of Interest Code are required to delete titles of positions that have been abolished and/or positions that no longer make or participate in making governmental decisions and revise based on updates to disclosure categories. #### **Background:**

The Political Reform Act of 1974 requires every local government agency to:

- 1. Adopt a Conflict of Interest Code identifying the reporting requirements of covered employees,
- 2. Review the need for any changes to its code biennially, and
- 3. Submit an amended code to the "code reviewing body" if necessitated by changed circumstances. (Gov. Code, §§ 87300; 87302; 87306.5, subd.(a).)

The Board of Supervisors is designated as the code reviewing body for independent districts and agencies with jurisdiction wholly within the County. (Gov. Code, § 82011, subd. (b).) Once approved by the Board, the Buellton Union School District's amended Conflict of Interest Code is deemed effective. (Gov. Code, § 87303.)
