Summary Text:

Attached is a letter from Mike Prater, Executive Officer of the Santa Barbara County Local Agency Formation Commission (LAFCO) requesting that the Board of Supervisors appoint one member of the Board to a four-year term from March 1, 2023 through March 1, 2027.

Background:

LAFCO is composed of two County Supervisors, two members of City Counsels, two directors of Independent Special Districts and a member of the general public. There is an alternate member in each category to vote in place of absent or disqualified members in that category.

County members are appointed to four-year terms and serve at the pleasure of the Board of Supervisors. The term of office of County Member Joan Hartmann will expire on March 1, 2023.

At the January 10, 2023 Board of Supervisors meeting, the Board made annual appointments to Boards and Commissions. At that meeting, the Board discussed LAFCO appointments and opted to keep the current appointments:

- Supervisor Hartmann (for term expiring March 1, 2023)
- Supervisor Williams (for term expiring March 1, 2026)
- Supervisor Nelson, as alternate (for term expiring March 1, 2026)

The Board therefore is being asked to re-appoint Supervisor Hartmann to LAFCO pursuant to its earlier action.
