Dear County of Santa Barbara staff,

I am writing in support of preserving Glen Annie golf course (Glen Annie), and not rezoning it for housing, as is being proposed under AB 672. Glen Annie is one of only two affordable golf courses on Santa Barbara's south coast.

I am both an avid golfer and a Glen Annie course marshal. I am always impressed with the diversity of those who come to play the course – young, old, male, female, multi-cultural, ethnically diverse, special needs, etc., and all having a wide range of golf skills. Golf at Glen Annie is available to everyone who wants to get outside for fun with friends and to make some new ones.

Targeting a public golf course to help solve the state's housing problems is short-sighted. Glen Annie is not just a golf course. It is a community resource and contributes greatly to the entire south coast area in many ways. Glen Annie is the home course for Dos Pueblos' boys and girls golf teams. It supports local corporations' golf leagues; and is also the venue for the very popular GNO (Girls Night Out) program which has introduced hundreds of women to the game of golf.

As a course marshal, I have learned that many people travel to the area to play Glen Annie. They stay in local hotels, and eat and shop in local restaurants and stores, which helps our local economy. Losing Glen Annie would force these people, as well as locals, to travel elsewhere to play golf, sending these dollars to other communities.

Glen Annie serves as a venue for charitable fundraising events. Many non-profits depend on their annual charitable golf tournament to survive. Glen Annie is the venue for the Santa Barbara County Auto Expo, which benefits our local youth's education. Glen Annie is home to countless charitable golf tournaments which benefit our local schools and colleges, especially their sports programs, which are generally underfunded. A partial list of charitable golf tournaments held at Glen Annie follows at the bottom of this email.

Glen Annie is a popular place for holding both indoor and outdoor events. It has a 350-person private outdoor dining area. The venue is popular for weddings, rehearsal dinners, banquets, corporate events, and celebrations of life. Glen Annie also regularly hosts wine pairing dinners, highlighting local wineries. All these events attract people to the area, which helps the local economy.

Glen Annie is home to an incredibly diverse wildlife including coyotes, deer, raptors, and reptiles. Converting their habitat to a housing development would further stress these animals and pressure their very existence.

In the event of a wildfire, Glen Annie serves as a protective buffer to nearby neighborhoods. Converting the course to houses would eliminate the buffer. It would also endanger those living in and around the site in times of wildfire, as Cathedral Oaks and Glen Annie roads are single-laned and are already congested with traffic from Dos Pueblos High School.

Lastly is the water issue. Whereas Glen Annie uses reclaimed water to for its fairways, new housing would put an even greater stress on our water supplies. While Lake Cachuma is currently full, it is for the first time in 12 years, where historically it has filled every two to four years. Goleta's groundwater basins are well below historical average levels; and as of this writing, the annual state water allotment is currently at 5%. Having sufficient water supplies is a serious concern, and adding additional housing will only add to the problem.

I understand that California has a housing problem. The solution will be multi-faceted and much more complex than the simple and misguided action of closing a public golf course. Losing Glen Annie would a huge loss for the community that could never be regained.
