Justification:

Increase Appropriations for Farmworker Resource Center (FRC) Grant Program

Budget Action: Increase appropriations of \$462,500 in Social Services WIOA-WDB for Salaries & Employee Benefits (\$150,000), Services & Supplies (\$187,500), and Capital Assets-Equipment (\$125,000) funded by unanticipated revenue from the State of California (\$370,000) and an operating transfer from the General Fund (\$92,500). Increase appropriations of \$92,500 in General County Programs General Fund for Other Financing Uses funded by release of Unassigned Fund Balance.

The State of California Department of Community Services and Development (CSD) awarded the Department of Social Services (DSS) a grant totaling \$833,000 to implement the Farmworker Resource Center (FRC) Grant Program. DSS must provide matching funds in an amount equal to 25 percent of the award, or \$208,250, during the grant term of February 15, 2023 through May 15, 2024. The County will use General Fund to meet the match requirement.

DSS projects to incur \$462,500 in grant-related expenditures through June 30, 2023. This budget revision will increase appropriations for salaries and employee benefits for staff who will deliver and coordinate services, operating expenses, and the purchase and upfitting of a van that will be used for mobile operations; it also facilitates the transfer of General Fund from General County Programs to DSS. DSS will build appropriations for the balance of budgeted grant expenditures in its FY 2023-24 budget.
