FIRST AMENDMENT TO THE AGREEMENT FOR OPERATION OF A FREE COUNTY-WIDE LIBRARY SYSTEM

This First Amendment to the Agreement for Operation of a Free County-Wide Library System for the 2022 to 2023 Fiscal Year (herein called the "First Amendment") is made this 28th day of March 2023 between:

The County of Santa Barbara, a political subdivision of the State of California, hereinafter referred to as the County,

City of Santa Barbara, a municipal corporation, hereinafter referred to as Santa Barbara, and

City of Lompoc, a municipal corporation, hereinafter referred to as Lompoc, and

City of Santa Maria, a municipal corporation, hereinafter referred to as Santa Maria, and

City of Carpinteria, a municipal corporation, hereinafter referred to as Carpinteria, and

City of Goleta, a municipal corporation, hereinafter referred to as Goleta.

RECITALS

WHEREAS, on July 12, 2022, the County executed the Agreement for Operation of a Free County-Wide Library System for the 2022 to 2023 Fiscal Year (herein called the "Agreement") and allocated \$4,396,429 towards the Operation of a Free County-wide Library System;

WHEREAS, on January 1, 2023 the County Orcutt Branch Library experienced an unforeseen rent increase in the amount of \$27,042 over the final six-month term of the Agreement which could not be absorbed without detriment to the Branch or its programs and operation hours;

WHEREAS, on December 14, 2022, at the County Library Advisory Committee meeting, staff and committee members discussed the County Orcutt Branch Library rent increase, as well as reviewed and considered the County Orcutt Branch Library's anticipated budgetary change resulting from this unforeseen rent increase;

WHEREAS, the County hereby wishes to amend the Agreement to increase the amount allocated to the County Orcutt Branch Library to cover this Branch's unforeseen rent increase, such that the operations of this Branch are not negatively impacted.

AGREEMENT

NOW THEREFORE, the parties hereby agree as follows:

1. Section 6 Deposit and Allotment of Funds, Paragraph a, which regards County's Contribution for FY 2022/23, is hereby amended to increase the Agreement by \$27,042, for a total contract amount of \$4,423,471 and shall now read as follows:

6. Deposit and Allotment of Funds

Contribution for FY 2022/23:

a. County agrees to contribute \$4,423,471 in Fiscal Year 2022/23, which sum provides \$3,791,298 for library services, a per capita level of support of approximately \$8.34 to be used for operations and acquisition of books/materials for each inhabitant of County, and an additional amount of \$632,173 is allocated to cover unforeseen expenses (e.g. rent increase) and to mitigate hours and programming reductions of County branch libraries at risk. For the purpose of making the allotments provided for in this paragraph for the 2022/2023 Fiscal Year, the parties hereto agree the population count in each of the library zones as determined in accordance with subpart 6.b below is as follows:
