For several years I have been involved with an interest group on Criminal Justice Reform with the League of Women Voters of California. Locally a small committee of League members have joined with the local CLUE (Clergy and Laity United for Equity) workgroup focused on the same issue. We are continuing to work with County Administrators and Safety Department officials to reduce the number of people housed in our County jails, especially the 30-40% who have behavioral wellness needs. Appropriate treatment in our County seems to be lacking, but I believe that there is interest in changing that. I'd like to help make that happen.
