I. <u>Purpose</u>

To mitigate risk to the County's technology hardware, software, services, and data. To also ensure that acquisitions are compatible with the County's technology hardware, software, services, and data.

II. Audience

The audience for this policy is all County employees, contractors, and third parties.

III. <u>Scope</u>

This policy applies to anyone acquiring or deploying technology, including zero-cost acquisitions in the County.

IV. <u>Definitions</u>

See ITAM-0602, Glossary of Definitions

V. Policy

Acquiring and deploying any technology in the County must be reviewed by the Departmental Information Security Officer (DISO) prior to acquisition, regardless of cost, including zero-cost acquisitions. Additionally, acquisitions and deployments must meet County enterprise standards and policies.

Any purchases where the total is above \$50,000 must have an additional signoff by the County CISO and Deputy CIO, unless otherwise required to be approved by EITC.

VI. Exceptions

If a Department is unable to meet the requirements of this policy, the department must consult with the CISO and provide sufficient justification for the request.

VII. Non-Compliance

Employees who fail to adhere to this policy may be subject to disciplinary action in accordance with civil service rules.
