Good morning Chair Williams and members of the Board of Supervisors,

My name is Landon Ranck - I am the Associate Director for the Santa Barbara Alliance for Community Transformation (SB ACT), a nonprofit working to address homelessness and housing insecurity across Santa Barbara County.

I write today on behalf of SB ACT in full support of the proposed Dignity Moves La Posada site. As an agency that has worked closely with homeless outreach providers, I can assure you that few things are more appealing to individuals who are hesitant to leave their encampments than the offering of tranquil, caring, non-congregate shelter settings such as Dignity Moves affords. Everyone just wants dignity, and Dignity Moves provides a level of individualized care that has truly changed lives in downtown Santa Barbara and helped dozens of individuals transition from street-level homelessness to housing.

Additionally, we are are well aware that between 40-60 individuals currently live at an encampment right near the proposed La Posada site. With the cleanups being enacted this month by both CalTrans and Union Pacific Railroad, we expect to see a continued shuffling of the individuals in or around this site. Dignity Moves La Posada is the best possible solution to quelling the fire hazard and public health concerns posed by this encampment. La Posada would provide a highly appealing alternative in a context that is already familiar and trusted by many of these individuals.
