NOTICE IS HEREBY GIVEN that the following matter will be heard by the Board of Supervisors of the County of Santa Barbara at its regular meeting on Tuesday, May 2, 2023 at 9:00 a.m. or shortly thereafter.

A hearing to consider an Ordinance amending Ordinance 5119 setting compensation (to increase the maximum increase from 3% to 5% tied to CPI-U), adjusting the timing of future increases to be effective in the pay period in which October 1 falls instead of Pay Period 1, memorializing the increase which will be effective September 18, 2023, and continuing to provide the same benefits Elected Department Heads receive such as County contribution rate for health and dental insurance, automobile allowance, and life insurance, and providing for future adjustments to Board member compensation.
